Sub: For Taking Prompt Steps/Action for Getting Sanction of Funds from the Govt. of NCT of Delhi for the Re- construction of Court Building and construction of Chambers Block at Dwarka Court.

Your Lordship, at the first place we wish to apprise the back drop of the urgency of the matter.

Sir, the Court building at Dwarka was constructed somewhere in year 2007, and its formal completion was taken place in year 2009. The Court building is of 8th Floor, consisting of 64 Court rooms and 64 separate retiring rooms for the Judges. The building has Four Wings i.e. -A, B,C, D.

Due to the sub-standard construction material, inefficient architecture and over all poor constructions, the building has developed number of cracks in the ceiling and walls of almost all the floors. Furthermore, the plaster along with concrete have been detaching and falling in large chunk and luckily on no occasion nobody was beneath the block of concrete otherwise same could have been resulted into casualties.

It is also brought to kind notice of your Lordship, nine elevators are also installed in the said building and due to the weakening of civil work, any of the elevators may collapse any day which may also turn in to massive toll.

Keeping in the view of the situation referred above the BMCC, Dwarka was apprised about the said situation and for that meeting with the concerned departments was taken place on 29/5/2024, which resulted in to the decision that the court building is beyond repair/set-right and the same has to be demolished and constructed a fresh. Nevertheless an astronomical amount is being incurred in retro fittings for temporary strengthening of the building.

However It has been discussed and decided that the demolition be carried out phase wise.—in four phases i.e. Firstly A Wing and after reconstruction of Wing A, thereafter B-C-D- in the similar manner—and prior to start of demolition of Court building, the construction of Chamber building on the vacant plot adjacent, to the court building, so that the functioning of the demolished wing of the court not be disturbed and for the time being can function from the proposed chamber building.

But since 29/5/2024 – last meeting of BMCC was held – there has been no progress with regard to the decision of demolition of existing court building or constructions of chamber block where the courts are to be housed temporarily. And even no meeting of BMCC was held till April 2025; but meantime on 21/4/2025 a huge block of concrete detached from the ceiling of balcony and fell on the ground, luckily no person was beneath. If there had been any body on the spot it would have turned into casualties.

This incident was also personally brought to the notice of your Lordship on the day of introductory meeting with Coordination Committee of all District Bar Association.

The above said incident occurred on 21/4/2025, was brought to the kind notice of Chairperson of BMCC vide letter dated 21/4/2025 and requested the chairperson to convene an urgent meeting to resolve the issue by President & Secretary of DCBA.

On the above said request, a meeting of BMCC was held on 05/5/2025 and in this meeting the issue was dealt on serious note and what has emerged that everything is on the anvil but it is the Govt. of NCT of Delhi who is delaying the financial sanction.

When the Chair Person of the BMCC Dwarka got to know about the delay in the financial sanction by the Delhi Government, having considered the gravity of the matter, decided to place the matter before your Lordship requesting for convening an early meeting with Chief Secretary, Delhi Govt.

Your lordship, it is not out of place to mention that thousands of stack holders — litigant, judges, police personnel, advocates, court staff, security staff, sanitation staff etc. – visit Dwarka court daily and the worsening structure of the court building may cause intense toll any day.
